


Built Environment

Your Feedback

The community of Denmark is expressing widespread dissatisfaction with the state of road infrastructure and maintenance in the area, highlighting a multitude of issues ranging from the poor condition of gravel roads like Parker Road to inadequate sealing and maintenance of existing roads. There's a consensus that road maintenance could be improved, with calls for actual utilisation of rates paid for upkeep. Residents emphasise the need for better drainage, more proactive maintenance, and higher accountability in asset management. Overall, there's a strong call for significant improvements to ensure safer and more reliable regional road networks.

The feedback highlights a pressing need for action on drainage issues, emphasising the importance of regular maintenance and upkeep. Residents express frustration with blocked drains, poor stormwater management, and inadequate drainage systems, which lead to flooding, erosion, and road damage. Many residents urge our Shire to prioritise drainage improvements, especially in areas prone to flooding, to mitigate the potential damage caused by heavy rain and ensure safer road conditions.


Natural Environment


We will protect and enhance our natural systems, which are vital to the sustainability of our local community.

Your Feedback

The feedback on animal management focused on concerns and suggestions related to the management and enforcement of bylaws regarding pet ownership, particularly cats and dogs, within Denmark. Overall, the comments reflect a desire for stricter enforcement of existing regulations and the implementation of new measures to address issues related to pet ownership and wildlife conservation.

The conservation and environmental management feedback focused on protecting natural bushland, native vegetation and waterways, weed control management, and rehabilitating degraded areas in our Shire reserves. The narrative theme from the community feedback was to ensure continuous improvement of conservation practice whilst catering for public recreational use through appropriate development and policy control. Feedback from the survey also suggests the community wants our Shire to continue to do more in the sustainability area, including continuing our program to transition to renewable energy, taking more action on climate change, promoting a more sustainable construction industry and implementing more sustainable waste management practices.

The community emphasised the need for improved hazard mitigation and disaster planning, particularly regarding bushfires and climate change impacts. Key points include a focus on hazard mitigation, promotion of fire mitigation, improved communication and planning, infrastructure and resource allocation, community education and engagement. Overall, the community is urging proactive measures to address the growing threat of bushfires, emphasising the importance of collaboration, communication, and practical solutions to ensure the safety and resilience of the region.

There is a strong call for better marketing and promoting Denmark as a tourist destination. Suggestions include advertising campaigns, improved signage, and increased visibility through various channels. Improvements in tourist facilities, such as better RV parking, public toilets, and enhanced access to beaches and attractions, are desired. Additionally, there are calls for better traffic management during peak tourist times and the development of more visitor parking areas. While tourism is recognised as vital to the local economy, there are concerns about striking a balance between catering to tourists and preserving the character and charm of the town for locals.

Residents emphasise the importance of involving the community in decision-making processes regarding future town planning and development. Public consultation is essential for developing a cohesive vision for the town centre.
