




It is named in honour of Percy Berridge who lived in Denmark for many years. Mr Berridge was once a gardener on the staff of the Queen of England and kept a beautiful garden in the grounds of the Butter Factory.

The park facilities, widely used by both local people and tourists, include a rotunda, children's play equipment, a jetty and provisions for craft fairs such as the Easter Fair. To the north of the Bridge, still on the town side, is Thornton Park, which also has a rotunda and manicured lawns sweeping down to the river edge.

The exterior walls are timber and the old roof has been replaced by tiles. It is a long rectangular building that has had a number of changes that hide the facade of the clubhouse.

This clubhouse has social and historic heritage significance. The railway station building was originally constructed in 1929 on the Denmark-Nornalup Railway line (corner Crellin Street and Hollings Road). In early 1964 the Bowling Club had no Clubhouse and, as all organisations at that time, very little funds. The Railway line, built in 1929 and closed in the 1950s, had been cleared and all buildings on the station site were to be sold. At the instigation of Shire Clerk F W Timothy, the Club tendered for and bought (through money raised by a Council loan) the station building which was transported and erected on the present reserve.

The Shire of Denmark adopted the Denmark Railway Station No. 3 Reserve Heritage Precinct Concept Plan at the Ordinary Meeting of Council held on 27 May 2014 (Res. No: 240514). This Concept Plan provides for the Old Railway Station Building to be relocated to this Heritage Precinct in recognition that the building was originally located in this Precinct.

Over the years alterations have taken place by filling in the old verandah and including it in the Clubroom but the essential character of the building remains as it was.



The CWA facility consists of an entrance hall where small meetings are held, with a large hall and kitchen. There is a small room off the kitchen with a servery into the large hall. There is a storeroom off the back verandah and toilet facilities. The building is close to the school, police station, ambulance and Red Cross organisation. The construction materials include fibro and weatherboard walls, wooden framed windows and a corrugated iron roof.

The CWA rooms consist of an old Group Settlement cottage resited from Lloyds Hill (now known as Silver Road) and a large hall built from materials from a dismantled school in Strickland Street, Denmark. The first part was opened in 1948 and the larger hall in 1952.

This building has historic, social and aesthetic heritage characteristics valued by the Denmark community. The CWA is an organisation that has been active in Denmark since 1934. It has enhanced the lives of many families in the district through times of depression, fire and war. The rooms gave rest and shelter to many women and children on shopping or market days. It has been a meeting place for many groups and organisations e.g. Child Health Sister, Kindergarten, Courts, Rural Youth, Lodge, RSL, Anzac and Church Services. It has been used to cater for emergencies such as fires and searches. Talks of educational value are also held there. The CWA has been instrumental in supplying help to many in need and distress.

Very important to the heritage of the locality. High degree of integrity/ authenticity. Conservation of the place is highly desirable. Any alterations or extensions should reinforce the significance of the place.

It is an example of early pioneer commercial architecture. Pressed tin wall panelling still remains on walls in both 'shops'. Bay windows used for displays for earlier businesses still hold their integrity.

Craig's Building has social, aesthetic and historical heritage significance. It is a fine example of early commercial architecture. It was built of local materials during Denmark's transition period from a timber town to Group Settlement. The building has been particularly robust and experienced a number of occupancies reflective of the demands of the community. These shops were originally used as a grocer, tearooms and drapery from the 1920s. By 2010 the building had become a doctors' surgery.



The site marks the east entrance to the Denmark townsite on South Coast Highway and is surrounded by reticulated gardens. A recently added large steel canopy over a sports court mars the appearance of the college to the Highway.

This place has historic, social and aesthetic heritage significance. The Denmark Agricultural College was first established in 1942 at State Farm. It was set up in response to the commandeering of Narrogin Agricultural School for war purposes. However, when Narrogin Agricultural School re-opened, Denmark continued the agricultural education of aspiring farmers by building their own facilities which were opened on 27 February 1947. The college was built to accommodate approximately 40 students in two year courses. Hundreds of boys (and latterly some girls) have studied agricultural subjects, played sport and socialised in the Denmark community. In 2010 the college has a student population of 90, most of whom live in as they come from many places throughout Australia.

Very important to the heritage of the locality. High degree of integrity/ authenticity. Conservation of the place is highly desirable. Any alterations or extensions should reinforce the significance of the place.

The oldest building on the Denmark Primary School site was built in 1935. It is a timber structure which originally comprised two schoolrooms. The building has been altered and extended over time. In the schoolyard is a timber structure, formerly Group 93 School from West Denmark. This was first used as a classroom, but now (2011) is the Denmark Family Centre.

In the 1960s a new long rectangular timber building with a corrugated iron roof was added. The verandahs which run the length of the building are enclosed with windows for protection from the elements. The buildings form a boundary to a hard surface play area. Additional buildings, sympathetic to the original style of the school, have been built. The school environs included generous grassed areas inside the external boundary.

The Denmark Primary School has social and historic heritage significance. It has contributed to the education of the Denmark children on different campuses for many years. With the close of outlying schools over the years and the growing school population, education became centred at this present campus after 1935. Since then the school has grown with numerous additions. In 2001, a new campus was constructed to house the Denmark High School, which allowed the site to remain exclusively as the Denmark Primary School. In 2010 there were 533 students enrolled at the school.

A time capsule celebrating the centenary of education in the district was buried on 30 November 1996, to be opened in 2046.

The Traffic Bridge, Number 86A, forms the eastern gateway into the town centre and is constructed of massive timber logs.

It is 9.8m wide while each span is approximately 6m. The total length of the bridge is 48.42m, has maximum head room of 7.62m and a footpath on one side that is 1.27m wide. The bridge forms a vital connection to farmland, Albany to the east and Mt Barker to the north.



The hospital buildings nestle in a parkland and garden setting.

It was built by Joe Thornton to incorrect plans as the Public Works Department supplied a Group house plan in error. All additions have been made keeping a unity of material and design. Architectural drawings are available. The trees in the grounds were planted during the Depression by unemployed men. In the far corner of the hospital block is a Norfolk Pine tree planted at the end of WWI, commemorating the end of hostilities and the return of peace. It is locally known as The Peace Tree. A new district hospital opened in 2009 and use of the old hospital is likely to change.

The Shire of Denmark granted planning approval in 2013 for the refurbishment of the Denmark District Hospital (Fmr) and Denmark Frail and Aged Lodge (Fmr) to the Morgan Richards Community Centre. In mid-2014 the building permit and associated tenders were let for the refurbishment works required.



Historic Theme: Community efforts Sub Theme: Community services

The Denmark District Hospital has social and historical heritage significance. Located in a spacious setting, the original hospital consisted of three wards, kitchen, operating theatre, office, back and front verandahs, separate Matron's quarters, shed and morgue. The Matron's quarters and the morgue have been recognised as having State heritage significance and are on the Register of Heritage Places.

The next addition was a permanent care ward which became a Hospice. In 1974 new offices, outpatients and operating theatre were added to the Hospital. It became a 17 bed hospital (though only funded for eight). Services provided include general medicine, obstetrics, home birthing program, health promotion (eg, arthritis, asthma, diabetes, parenting conferences), palliative care, aged care, emergency care, radiology/ ultrasound and a visiting pathology service. Only minor surgery was done as no theatre operated. An increasing aged population has resulted in the need for frail aged care and accommodation. The hospital was staffed by seven people over a 24 hour period.

In 2008/9 a new hospital was erected on the old Denmark Agricultural Research Centre site.

Level of Significance

Exceptional

Essential to the heritage of the locality. Rare or outstanding example. The place should be retained and conserved unless there is no feasible and prudent alternative to doing otherwise. Any alterations or extensions should reinforce the significance of the place, and be in accordance with a Conservation Plan (if one exists for the place).



The house is large by Denmark standards and commands a prominent high position with a generous outlook over the townsite and distant rural land. The house is symmetrical with central steps leading to the entrance. Extensive restoration work has been carried out, in keeping with the original design.

The house has a distinctive architectural style which gives it aesthetic heritage significance. It also has social and historic value. During its history it has been used for a variety of purposes. Built around 1910, the building was originally located in Kalgoorlie. In 1924 it was brought to Denmark where it was reconstructed. It was built as a home for maternity patients who came into town from isolated areas to give birth. It opened in 1928 as the Eva and Alfred Carson Maternity Hostel (they were sponsors). It was also used as an Infant Health Clinic. In 1941 the house was bought by Mr Buckingham, the first principal of the Denmark Agricultural School. The house was later sold to the Public Works Department for use initially by headmasters and later as a boarding house for single teachers. In 1997 it was a private residence which had been carefully restored by the previous owners 1994-1996. In 2010, the building was used as a restaurant.

This is a simple timber cottage, with a tin roof and a verandah across the front elevation supported with timber posts with decorative corner supports. The John Clark Memorial Bandstand has aesthetic, social and historic heritage significance.

John Clark was born in Scotland in 1879. He came to Denmark in 1908 where he took up farming until the 1920s. In 1927, after being granted a hotel licence, he built the Denmark Hotel which he and his wife operated for a number of years. In 1940 he built Edinburgh Guest House. Mr Clark had played in a band in Scotland as a child. In his will he left £2,000 to the Shire of Denmark which then decided to allocate these funds to the Denmark P&C Association during the 1960's to purchase instruments for a Silver band (the John Clark Memorial Silver Band, the first school band in WA). He also donated £2,000 to the then Denmark Road Board to build a bandstand on the small reserve opposite the Catholic Church (John lived in one the houses on the other side of this park). The Shire Clerk FW Timothy discussed this matter with Council and was authorised to negotiate with the Perpetual Trustees as Executors of John Clark's Will, and with his son and daughters, to change the location of the proposed building as everyone agreed the designated site was most unsuitable. The Trustees and Family agreed to have the bandstand erected on the eastern side of the river so that the western side could be used as an auditorium. At this time the Esplanade was in a very poor state - no toilets or facilities of any kind and the Council had not money to provide them. Funds were available from the Tourist Development Authority to erect toilets but Council had to provide \$1 for every \$2 granted. Through careful negotiations it was arranged that money spent on the Bandstand could be used as Council's share of funds to erect toilets on the Esplanade and the town benefited in two ways from the legacy. The Esplanade opposite the bandstand was terraced and grassed to provide seating for audiences. Unfortunately over time this has been neglected and now does not exist. Both buildings were erected by ND Thornton. In 2014, remedial works were undertaken to the roof and foundations for structural integrity purposes.



Poison Point represents a key feature in the Wilson Inlet Cultural Landscape. The granite outcrop above Poison Point contains evidence of Noongar people quarrying dolerite and producing stone tools, as well as a large gnamma hole and important fresh water source. There is an old scar etched into the bark of a tree that is consistent with those used as markers by Noongar people during traditional times.

In addition to the archaeological features present at Poison Point, the area is of particular importance to the contemporary Noongar community as a cultural site. The Poison Point granite outcrop is a registered site in the Department of Aboriginal Affairs heritage register under the title Denmark Quarry. A second site is also registered under the title Inlet Drive Granite Outcrop. Both sites are part of the same complex and are situated within a 300m radius of one another. The sites have been registered separately due to the artificial division created by Inlet Drive.

The Denmark Quarry site file describes the site as "outcropping dolerite dyke through granite showing evidence of low level utilization; number of artefacts 100 plus; cores and flakes". The Inlet Drive Granite Outcrop site file describes the site as "numerous dolerite flakes over a granite outcrop; over 500 flakes on site; cores, flakes, blades, small number of quartz flakes, balls of Balga [grass tree] gum; contains holes that may have been used for water." Traditional Owners have continued to maintain this cultural site and have been conducting weed management projects in the area with Denmark Weed Action Group. Maintaining the natural values at this important heritage site represents continuing cultural practices and ongoing links to the site.

The railway precinct became the centre of railway operations in Denmark at the opening of the Denmark – Nornalup line in 1929. Prior to this, there had been two separate stations in Denmark, but this was by far the largest. It was situated by the rivermouth, where the Denmark River flows into Wilson Inlet.


The Bridge over the Denmark River was constructed when the line from Albany was realigned to connect with the Nornalup extension which opened in 1929. The reason for the realignment was to reduce gradients when the line left Denmark and progressed westward. The bridge was of traditional timber pile construction, and is currently used as a pedestrian bridge which connects to the Wilson Inlet Heritage Walk Trail.

The 60 foot Turntable, which was used to turn locomotives, is the oldest and only remaining example of its type in Western Australia. It was built by William Sellars and Co. in Philadelphia in 1896, and first installed at the Northam depot. When it was no longer adequate to be used on the larger steam locomotives on the Kalgoorlie railway line, it was moved to Denmark and was first located on the old line near the Denmark Hotel, upstream from the rivermouth. Here it was used to turn terminating locomotives on the Albany – Denmark route, before the Nornalup line was completed. Later, when the new station was built, it was moved there.

The ashpit was lined with concrete and its purpose was to contain the ash from the steam engines. The fireman on the engine would clean out the 'clinkers' into the ashpit to maximise the power that a clean firebox could generate. When the ashpit was full, the fettlers, or line maintenance men, would clean out the pit and deposit the cooled ash elsewhere.

This turntable was used to turn the locomotive around when the train journey ended at Denmark instead of Nornalup. It was relocated when the line was rebuilt to follow the foreshore of the inlet and extended to Nornalup. The line which came into town was then closed. The ash pit was built at the time of the construction of the new line in 1929.

The Shire of Denmark adopted the Denmark Railway Station No. 3 Reserve Heritage Precinct Concept Plan at the Ordinary Meeting of Council held on the 27 May 2014 (Res No: 240514) to guide development and use of the Reserve into the future.













Significance

Historic Theme: Historic, Research Sub Theme: Social, Rarity

All three items in the railway precinct have considerable historic value, with their connection to the Denmark - Nornalup Railway, which ran from 1929 to 1957. The railway, which was originally intended to link up with rail lines at Pemberton (but this plan never eventuated), was a significant lifeline to the isolated communities, chiefly in Group Settlement areas between the two towns. Much of the railway history in Western Australia has been lost and this precinct is a significant example of the historic importance of rail, prior to the advances in motor vehicles and road technology.

The Turntable and Ashpit have some research value. The Turntable is a rare example of rail technology from the 19th century which is now obsolete. The Ashpit is linked to the importance of steam as a mode of energy in transportation. The ready availability of timber to power steam locomotives resulted in the waste product of ash, and this was a resource that required disposal. The Ashpit is an example of that method.

All items in the Precinct have significant social value which relate to the town and outlying region in the period from 1929 to 1957 and beyond. The Group Settlement Scheme was one of the most important periods in Denmark's history, and the railway, and its associated infrastructure, was the means of linking those isolated settlements to the larger community of Denmark. The railway was a means of transporting provisions and produce in both directions, as well as providing essential medical services in emergencies. The railway also played a small part in the increasingly important tourism industry along the South Coast of WA.

The Turntable has considerable rarity significance, in that it appears to be the oldest and only remaining example of its type in Western Australia. It was built by William Sellars and Co. in Philadelphia in 1896, installed at Northam and moved to Denmark in the 1920s.

In 2014, a new concrete deck and new railing work was undertaken to sustain the life of the bridge. The Bridge also requires new cross bracing and work on the abutments in the near future.



The single storey building was originally built as a Butter Factory and was constructed in timber and iron. The roof line of the building, though showing little continuity of design, is interesting, with a range of gables set at angles to one another.

The Butter Factory has aesthetic and historic heritage significance. First built in 1926 by the Great Southern Butter Co, the factory operated for many years during the local dairy farmers' production of butter. It was originally clad in asbestos but soon after was virtually rebuilt in brick. In 1955 it passed into the hands of the Sunnywest organisation who operated there until 1973. For several years it lay unoccupied, declining into a state of disrepair. In 1979 it was recognised as a good site for a wine cellar and the Goundrey family took on the job of restoring the building. Restoration included reroofing, painting and plastering as well as rejuvenation of the grounds. The old palm trees on the property are said to have been planted in 1935 by Percy Berridge, a former gardener to the Queen of England. Goundreys continued to run the Wine Cellar until around 1996. In 2010, an antique business operated from the premises. Within the same complex as the Butter Factory is Mrs Jones Cafe (previously known as the Mary Rose Tea Shoppe) which was added in keeping with original buildings.



This place has aesthetic, historic and social heritage significance. The building is significant in that it was the first permanent police building in Denmark. Prior to 1923, Denmark was policed from Albany. Constable PO Johns was made officer in charge in 1911, setting up office in a building near the river in 1912. However this police service was soon discontinued and for another ten years Denmark went back to being served by police from Albany. The police station built in 1923 is directly related to the great influx of population under the Group Settlement Scheme. The plans for the office and cells, the police quarters and stable were drawn up in 1920 but the buildings were not completed until June 1923. The stable was located near Mitchell Street on the site of the present Police Quarters.

The first police officer in charge in 1923 was Constable F Cook. Through the Group Settlement years the resident constable had to do his rounds on horseback. When not stabled, his horse was kept in a paddock on the site of the present Police Station. In 1938 a Constable AJ Farrier is said to have travelled approximately 135km per week on his rounds. The longest serving police constable in the Old Police Station was Constable FH Bibby who served from 1948 to 1958. When the new Police Station was built in 1985 the Denmark Historical Society wrote to the Minister for Police asking for the old station to be transferred to the Shire of Denmark for museum purposes. This was approved and with Council encouragement the Historical Society took over the site in 1987 and set about collecting objects and setting up displays. After two years work the Mueseum was opened on 4 March 1989 by Valerie Milne, Curator of the Albany Residency Mueseum. In 1993 old plans were found of the Police Station and these were presented to the Denmark Historical Society at an official function at the new Police Station. In 2010 the Denmark Historical Society still operates from the museum which contains interesting photographic displays.

He left to gain further experience and worked in Mt Barker, Craigs and then later set up a business under Endinburgh House. He bought Nockold's shop and the family still owns the business.



It was erected in a company timber town in the hey day of milling in this area. There are many notable features of this karri timber building. The basic structure is still sound. Much of the floor still bears the marks of where rough boards were used. Originally the Church faced Strickland Street, and access was by step. After the cemetery was opened in Denmark (about 1910) and funerals were taken in the Church, the stairs were too steep to carry a coffin in and out. The interior was turned around and the entrance placed away from the street and the altar end moved to the west in 1913. The Strickland Street windows give light to the altar inside.

The interior is lined with Baltic pine and features an unusual Gothic arch in the sanctuary. The detailing and use of Baltic Pine are said to reflect the influence of Norwegian mill workers from the time of the construction of the building. Modern zincalume has replaced the original corrugated iron roof. Timber struts were placed on the southern side of the building to help stabilise the church after it was damaged during Cyclone Alby (1978). These have been retained to record the damage done to the building and as a structural necessity.

Early in 1898 church services were being conducted in Denmark by the Rector of the Albany Parish, the Rev. Howell Griffiths. At one stage services were held in the local public hall. Construction of St Leonard's began early in 1899. Percy Harrison designed the church and Millars donated the land and provided structural timber at a discounted price. The church was built using voluntary labour. In October 1899 Bishop Riley dedicated the building. In 1905 the church was closed when the sawmills shut down and Denmark's population declined. It reopened in 1909, and in 1914 the local church committee decided that the church should bear the name of a patron saint, rather than remain known as 'The Mission Church'. Bishop Goldsmith chose the name St Leonard's. Around 1914 the porch which had been located on the eastern side was relocated to the western end as access for coffins and processions were difficult up the steep front steps. The arch, sanctuary and ancillary rooms, which had formerly been located at the western end of the building, were relocated to the eastern end. Severe damage to St Leonard's Church was caused by Cyclone Alby in 1978. Cyclonic winds destroyed much of the roof and lifted the church partly off its stumps. Timber struts were placed on the southern side of the building to keep it upright. These have been retained to preserve that part of the church's history. St Leonard's Church is the oldest public building in Denmark and has been recognised by the Australian Heritage Commission (AHC). The AHC has listed St Leonard's on the Register for the National Estate and gave funds towards its renovation which began in 1989. The building is important to the function of the local Church community.

Renovation/restoration works in line with the Conservation Plan for St Leonard's Church commenced in 2013.

The town soon had three timber mills and the population swelled. The Millars were unsuccessful in gaining permission to extend their activities into the Deep River area. By 1905 the timber resources in the Denmark area were depleted and the Millars were forced to close their timber mills at Denmark. In the early 1920s Denmark experienced new growth with an influx of settlers under the Group Settlement Scheme. Although the Scheme itself did not prove to be successful, some of the new settlers stayed in the district and Denmark soon developed into an agricultural community.



To make more room, the Minister's accommodation unit at the back of the church was incorporated into the building by the removal of walls. However there was still insufficient space so Mervyn Anderson encouraged the building of a new church. Planning approval for the erection of the new building on the site of the old church was denied as there was insufficient space for parking, so the present site was chosen. In 1983 the opening ceremony filled the church to capacity. Though the Uniting Church has decreased in membership over the past few years, the active worshipping congregation appears to have stabilised approximately 30-35 people. Events such as weddings, however, still attract a 'full house'. In 1997 the installation of a self-contained pipe organ is planned. This will add to the musical life as, owing to the good acoustics of the church, classical recitals and concerts already attract many people.

The former teacher's quarters was constructed of timber weatherboard and plasterboard. It has a corrugated iron roof. The house has a central passage, front and back verandahs, a lounge room and a kitchen/dining room. Changes to the house include the removal of an internal wall which was subsequently replaced between the kitchen and bedroom, a new entrance provided in the left hand side of the house to give access from the carport and the verandah enclosed. The carport and garage have been added without affecting the main building. The old wash house is still at the back of the house. Remnants of a very old septic system and leach drains can be found in the back yard.

The former teacher's quarters is situated behind the RSL hall in central Denmark. It was a three bedroomed home but one bedroom has been incorporated with the kitchen to make a kitchen-dining room. It was built in 1916 by A E Green for the Public Works Dept for an estimated price of £498.17.0 and the teacher and family moved in on the 17 June 1916. It appears that the first teacher to live in the house was S M Darragh as he wrote on 1 May that he was living with his family in a boarding house because the new quarters were not finished and the old quarters were unfit for habitation, having been condemned. A copy of the original house plan is available as are copies of letters concerning the terrible condition of the previous teacher's quarters and events after the Darraghs moved in. The house was in the care of the Government Employees Housing Authority from 16 January 1974 and was sold to Peter and Monica Boyes on 15 January 1981 and Elizabeth Ivy Giles on 8 July 1982. On 12 October 1984 it was acquired by Kerry and Lynda Halse who sold it on 30 January 1998 to Clive and Fay Malcolm, the present owners.

The house has a place in the history of education in Denmark. It appears to be the first purpose-built teacher accommodation. It was necessary because of the predation of termites on the previous karri timber house used by the teachers. The new quarters housed Mr Darragh and his family and subsequent teachers. It was Government housing up until 1981 for a period of 65 years and has survived in very good condition. Mr and Mrs Halse needed to extend the house but rather than alter what they believed to be an important old building they sold it to the Malcolms who they understood wished to retain the integrity of the house and have it heritage listed. The house is the remaining building on what was the original school site and included all of the land bounded by Strickland, Bent, Price and Mitchell Streets. The area included a school (reported in December 1910 to have two airy well lit rooms), the old quarters (which although condemned for living were suggested by the teacher Mr Tuke as suitable to make into an extra room for the school), and the girls and boys toilets close to Price Street. The boys' toilet was close to Lot 42 and when the new quarters were built it was realised with some concern that from the kitchen, bedroom and verandahs the male teachers and the boys could be seen relieving themselves. A closed picket fence at a price of seven pounds was suggested.

The Post Office which was moved from its original position in Strickland Street is now located on the corner of Inlet Drive and Crellin Road. It is in a bush setting surrounded by mature trees. The Denmark Post Office was constructed in 1926 in a prominent position on Strickland Street, not far from the current Bankwest building and in a similar location to the current post office. The complex operation of the removal and relocation of the building captivated the town and the very slow task was successfully completed in 1987.

The Shire of Denmark adopted the Denmark Railway Station No. 3 Reserve Heritage Precinct Concept Plan at the Ordinary Meeting of Council held on 27 May 2014 (Res. No: 240514) to guide development and use of the Reserve into the future. In considering the Concept Plan, Council also resolved that an expanded Spirit of Play School at the site is not considered a long term complementary use at the Heritage Precinct.







The Denmark Environment Centre was started by an environmental group in 1987 and the mural was painted as a community project in the early 1990s. The other units have had sundry occupants over the years. By 1999 the Environment Centre added wooden buildings to the rear of their premises which in 2009 housed the Green Skills environment business and the Centre's offices and meeting room.



This Denmark Environment Centre Building Project was made possible through the generous support of local residents, businesses and the Gordon Reid Foundation for Conservation (part of the WA Lotteries Commission).

In 2009 a large fire seriously damaged the rear of the building that housed the Denmark office of Green Skills, the Denmark Weed Action Group and the Centre's offices and meeting room. The Shire of Denmark granted planning approval and a building permit in 2014 for new additions/alterations to the Denmark Environment Centre in the area that was destroyed in the fire. Still under the ownership of Jack Clark, renovations to the Guest house were carried out in 1953. Clark died in 1956 and since his demise the guest house has been through various owners/managers. One of these, Colleen and Gavin Faed, made extensive internal improvements in the 1990s to bring the standard of accommodation up to modern standards. They sold the business in 2003 and since then a number of owners have operated the business. In 2008 it was closed down to be reopened under another management arrangement. At some stage, date unknown, Edinboro House, as it was first named, was changed to the traditional spelling of Edinburgh.

These historical notes have been derived from the Register of Heritage Places - Assessment Documentation of the Beverley Infant Health Centre. Prepared 19 August 2008.

The Denmark Infant Health Clinic was built on Denmark town's first school site in 1956.

Interest in mother and child health dates from the turn of the 20th century over concerns about high levels of maternal and infant mortality. The Public Health Department attempted to counteract this through the establishment of the Midwives Registration Board and the employment of visiting nurses who could help 'train' mothers in infant health care. Although the Children's Protection Society introduced to Perth a pilot infant health clinic around 1920, it was recognised that a state-wide infant welfare service was needed. As a result of a conference held in 1922 at the instigation of the Children's Protection Society, the Infant Health Association of Western Australia was formed in 1923 to work in conjunction with the Public Health Department. In this year, three clinics with full time nurses began to operate in the Perth area and in 1924 clinics started in Fremantle and Northam.

The number of infant health centres grew steadily over subsequent years. The centres received a £100 a year subsidy from the Health Department but relied largely on local government and community fund raising for support. Sub-centres were established as satellites of a centre where an Infant Health nurse was resident. In the 1930s, the service faced a funding crisis and the community felt the government should be providing a larger share of the financial support. The work of the Infant Health Nurse included weighing babies, discussing their progress and any problems with their health and development with the mother, and referring sick babies to a doctor or hospital. The Infant Health Centre was seen as an educational institution for mothers and one of the main aims of the clinic was to help and teach mothers how to provide for the good health of their infant 'hoping to help her to produce a happy, healthy, well-adjusted Australian citizen'. Wartime stringencies cut deeply into the training of nurses and the financing of Infant Health Centres in the state, but their worth had been proven by 1942, when, after 20 years of operation, statistics showed that the infant mortality rate had been cut by 48% from 64 to 33 per 1,000 live births.

On 1 July 1945, the State Government took over responsibility for Infant Health Centre nurses' salaries and travelling expenses, with the assistance of the Lotteries Commission and local Road Boards, while it remained the responsibility of local committees to provide amenities and transport, significantly reducing the funds they needed to generate locally.

There were at that time 31 infant health centres and 72 sub-centres in the state, providing a total of 3,180 consultations a week and serving 90% of infants and their mothers.

Use of Infant Health Centres increased during the late 1950s to 1970s, with more children in the 1-2 and 2-5 year age brackets being seen as mothers continued to bring their children past the infant stage. In 1970, Infant Health Services were linked to the school medical service and referred to as Child Health Services. Infant Health Centres began to be referred to as Child Health Centres although there does not seem to have been any official change of title, with many centres still being called Infant Health Centres. In 1976, Child Health Services combined with Community Health Services to become Community & Child Health Services as it was deemed necessary that there should be a closer working relationship between the Child Health nurse and the local general practitioner. In the 1980s there was difficulty filling rural vacancies for nurses, combined with an increasing workload because of a rise of 10% in births from 1980-83. Rather than operate separate Infant Health Centres in isolation, it seemed preferable to provide service from larger health campuses with modern facilities and shared administration and building costs. Gradually, the various infant health centre buildings were vacated but some continued to occupy their own premises for some time. This was more common in rural areas where other health faciltities were not always available in the town.

When Denmark Infant Health Centre was closed it stood vacant for sometime before becoming home to the Denmark Arts Council. The Arts Council still occupied the old health centre in 2009.

The Denmark Infant Health Clinic has historic, social and representative heritage significance. Located on the north east corner of Strickland St and the South Coast Highway, this single storey building with cantilevered verandahs dominates the corner position. Morrison's was part of Richard and Robert Nockolds Stores which were built in about 1918. The corner building was run by Nockolds as a newsagency and bakery until they opened a business in Walpole and leased the corner building to Alan McWhinney, who transferred his Strickland St Chemist business to the corner shop. Times in the 1930s were hard and the McWhinneys did not stay long in Denmark and the shop was leased to Noel Morrison in 1934 who later bought it from the Nockolds.

Morrisons ran it as a newsagency, tobacconist and chemist with gifts, cards and many other lines and agencies. Noel Morrison's son Peter took over the reins in 1958 dropping lines like pharmacy as specialist shops were established in Denmark. The area where the Bibbulmun Café was situated in 2009 used to house a snooker room and hairdressing salon. The bakery next door continued under various owners until 1997 when Morrisons resumed this area to extend their newsagency and stationery interests. In 2009 Morrisons was a busy shop with Lotto and ANZ Bank agencies, drycleaning, books and newspapers. Peter's son Craig (the third generation of the Morrison family) still managed the business in 2009.



Murphy's workshop is located on the west side of the Denmark Historical Society Museum (formerly the Denmark Police Station) in Mitchell Street. It is a large rectangular corrugated iron building with a gabled roof (though the peak of the roof is unusually slightly curved.

William (Bill) Murphy built this workshop in 1948 using prefabricated metal frames imported from Sweden. He commenced business doing general farm machinery repairs and also had an International Harvester Agency. In 1950 Bill's brother Alan started working for his brother and another partner, Tassie Rice, joined them in the business.

In the late 1950s Bill chose to take up a teaching career and Alan carried on the business. He was an excellent tradesman with amazing skill and knowledge – his workshop was always active with local farmers and the horse racing fraternity calling to have metal work and repairs carried out by him. Alan continued working until late 2003 and he died in 2004. His workshop was leased to Wildwood Galleries which opened it for a short while. In 2009 it was run as a private workshop.

In 2013, the Shire of Denmark named the laneway to the west of the site as "Murphy Lane" in recognition that the Murphy's owned and resided at 1 Short Street for over 60 years and the property is still held by the family, and that Bill Murphy was a Councillor with the Shire of Denmark (served from 1955-1961 and 1962-1963).



The Reeves and Co butcher shop is located on a block next to the town's War Memorial in Hollings Rd. The single storey brick shop has a stepped parapet above the bull nosed verandah which hides the roof. Reeves and Co was originally built by the Bayley Brothers in the late 1910s/early 1920s as a butcher's shop. The building stands on its original site – with extensive alterations externally and internally made in the mid 1920s. The three Bayley Brothers came to Australia in 1911 (and to Denmark in 1912) and Norm and Ernie ran the butcher's side of the business. The third brother Frank farmed at the top of Horsley Rd where the Bayley property stands on Bayley's Hill. A fourth brother Fred joined them after WWI running the dairy side of the business.

The business was sold to the Thompson (Max) family in 1951 and they developed an abattoir west of town (since demolished). The Thompsons ran it for some years before selling it to the Reeves Bros who also operate in Albany. In 1994, the shop was taken over by Mike and Rosie Silver and Shane Russell.

The Reeves and Co Butcher Shop has aesthetic, historic and social cultural heritage significance. It has streetscape value and its small and simple design is valued by the community. 

The need for a frail and aged facility in Demark was recognised in 1982, and a Steering Committee was formed to take the project further. Substantial fundraising by the local community, augmented by government funding and a Lotterywest grant enabled building to commence in 1989. The first residents took up residence in June 1990. The Lodge was managed by the Denmark Association for the Care of the Frail Aged and Disabled (Inc.), but control was handed over to the Denmark District Hospital in 1998.

The Lodge was built adjacent to the Denmark District Hospital in natural bushland, on land which slopes down to a small stream, Millars Creek. The Lodge was staffed on a round-the-clock basis by carers who did the cooking, shopping, cleaning and administration.

When the Denmark Hospital closed in 2008 to move to a new building, the Aged Care Lodge also closed as the new hospital had facilities to cater for the needs of those residents. The Shire of Denmark granted planning approval in 2013 for the refurbishment of the Denmark District Hospital (Fmr) and Denmark Frail and Aged Lodge (Fmr) to the Morgan Richards Community Centre. In mid-2014 the building permit and associated tenders were let for the refurbishment works required.

Significance

The building has social significance as it is a good example of self-help in a community that saw a need for a facility and then set about raising a substantial amount of money for its construction and implementation. Condition: Good Integrity: High The six-pounder anti-tank gun weighs approximately 1140 kg and is 2.82 metres in length. It was extensively used by Australian troops in World War II. The gun was used until 1960 on a worldwide basis.

Unlike the 2-pounder (which it replaced), the new six-pounder gun was mounted on a conventional two-wheeled split trail carriage. This gun includes the optional side shields which were issued to give the crew better protection.

There are only two of these guns left in Australia, and this is the only one of its type in Western Australia.

History

Construction Date: 1940s

Architect: Builder:

The six-pounder anti-tank gun was developed during World War II in England, to replace the less effective two-pounder gun. Over 15,000 units were produced between 1942 and 1945, and the gun was used in the North Africa and Normandy campaigns to good effect. It remained the chief anti-tank weapon until 1960 when it was finally declared obsolete.

After the war ended, the Australian government allowed local authorities to bid for war trophies and it was under this scheme that the gun came to Denmark.

The Denmark Road Board, as a memorial to World War II soldiers, sourced this gun. Percy Berridge was the instigator of its acquisition, and it was initially placed in what was called Coronation Park but is now called Randall Park (cnr. South Coast Highway and Welsh Street). During the 1950s, the park was affectionately known as Percy's Pop Gun Park.

When the Returned & Services League (RSL) resumed the use of their hall in Strickland Street, after its period at the Denmark Visitor Centre, they decided to move the gun and its carriage to that site, where it sits today (2010).

Significance

Historic Theme: Historic, Social, Rarity

Sub Theme:

The World War II six-pounder anti-tank gun has considerable historic significance. Its place in military history, particularly in its role in the Allied victory in World War II, was notable, and its continued use until 1960 in other conflicts proved its effectiveness.

The six-pounder gun also has social significance in that a number of Denmark residents saw service in World War II and the gun's relocation to Denmark was a mark of respect for those servicemen and women. The Denmark sub-branch of the Returned & Services League continues to be an important part of the social fabric of the community.

The six-pounder gun also has considerable significance of rarity, in that it appears there are only two such guns in Australia, and this is the only example in Western Australia.

Overall, the precinct demonstrates an ad-hoc development sequence that is both organic and informal, giving the precinct an aesthetically pleasant streetscape, with informal verge treatments, mature plantings of mixed species and mostly generous setbacks. The streetscape is enhanced by its graduating elevation. The built heritage comprises a mix of original residential, public and civic buildings, although more recently some minor commercial activity is present owing to adaptive reuse of heritage buildings into shops and a restaurant.

The Mitchell Street Precinct has aesthetic, historic, social significance in that it contains many of the earliest buildings to either be constructed in or relocated to the Denmark townsite as well as examples of early and substantial tree plantings. Mitchell Street would have been the centre of much of the early civic and social activity of the community from after settlement. Taken together, the individual buildings are representative of the various needs and way of life of the early settlers and the amenities they had to support the local community. As well, it is reminiscent of an early streetscape through its informal and eclectic mix of form, fabric and layout.



The Stationmaster's House was built in 1928, in preparation for the opening of the Denmark-Nornalup railway the following year. The railway itself was an extension of the line that already existed between Albany and Denmark, which was originally part of the timber-cutting industry pioneered by the Millar Brothers in the late 19th century.

The house was part of a complete railway station complex which consisted of the station building, the stationmaster's house, barracks, three sets of lines, ashpit, turntable, stock yards and good sheds.

The station itself was just to the west of the Demark River, at the mouth to Wilson Inlet. The line crossed the Denmark River via a newly-constructed timber bridge.

The House was surrounded by a pretty garden and it was located in an attractive forest setting.

The responsibilities of the Stationmaster were many. He had the duties to schedule the movements of trains and to record the goods that they carried, collected and dropped off. He needed to know the safety requirements, rules and regulations of the Western Australian Government Railways (WAGR) which was the government authority in charge of railway operations. One of the Stationmasters in Denmark, J E Sanderson, who was employed there from August 1946 to January 1951, was the father of the Governor of Western Australia, Lieut-General John Sanderson (2000-05).

The house was originally located on Lot 1085 (2) Hollings Road. It was relocated to Lot 1792, on the corner of Ocean Beach Road and South Coast Highway in 1963 and adapted for use as the Denmark Kindergarten. It was later replaced near its original site at the Denmark River mouth on the railway reserve. It is presently (2010) used by community groups.

The Shire of Denmark adopted the Denmark Railway Station No. 3 Reserve Heritage Precinct Concept Plan at the Ordinary Meeting of Council held on 27 May 2014 (Res. No: 240514) to guide the development and use of the Reserve into the future.

The building has historic significance due to its strong connection with the railway that ran to and through Denmark from its earliest days. Specifically, it holds strong memories of the Denmark – Nornalup line that ran from 1929 to 1957. The stationmaster's role was of paramount importance in the successful running of the railway and the subsequent communication links between the township of Denmark and the remote settlements to its west. The Group Settlers especially found the railway vital in the transport of provisions and medical services.

Stationmasters became obsolete once the railway closed in 1957, but the building retained its historical significance when it became the Denmark Kindergarten in 1963 and played a key role in the early childhood education of many Denmark residents.

The building has representative significance in that it is one of many buildings in Denmark that has been relocated, not once but twice. The traditional timber construction, using the produce of the local area, is ideally suited to relocation and allows significant buildings in Denmark to retain their utility despite their age.

The original part of the Cemetary (dived into four parts – and labelled "Primitive Methodist, Church of England, Roman Catholic and Presbyterian") consisted of half an acre cleared in the centre of a ten acre reserve. The first burials were conducted in 1910 when four children were buried. Later a portion of 20ft x 20ft in the (then) extreme north west corner was fenced off to be used as a Stillbirth section. The first official plans were drawn up in 1919 by Surveyor Fenton at the cost of £7.7.0. This amount had to be paid in yearly instalments.

The Shire of Denmark adopted the Denmark Cemetery Development Concept Plan at the Ordinary Meeting of Council held on 6 May 2014 (Res. No: 060514) to guide development and use of the Cemetery Reserve into the future.

This place has historic and social cultural heritage significance. This is the last resting place of many of Denmark's pioneers. Many headstones are typical of a past age. Maternal tragedies (many young mothers and their babies died in circumstances which would not occur today) and many premature deaths caused by accidents also took their toll. The early deaths reflect the extreme loneliness, isolation, stress and hardship faced by the early settlers. The cemetery is still in use.



The single span steel frame bridge, supported by timber piers, carried a single 3'6" gauge railway line across the Denmark River. The southwest end entered the Denmark Station yards. The tracks have since been removed and replaced by a concrete surface. Handrails have been added to provide protection for pedestrian traffic.

The Denmark River Railway Bridge has aesthetic and historic heritage significance. It played an integral part in Denmark's economic development by forming part of the rail link from Albany to Denmark and then on to Nornalup. This pisé de terre (rammed earth) house is located at the top of a hill at the end of a steep winding drive, giving it a commanding view across a valley. The house appears to have been constructed using the pisé technique of rammed earth made from local gravel and mud. On closer inspection this may be a wattle and daub house. The roof is corrugated iron, and the verandah, which is under a separate roof, extends around three sides of the house. A double hop at the rear section gives the roof an interesting character. The Masonic Lodge Hall is of a simple rectangular design. It is built from brown bricks and a corrugated iron roof. The square windows are placed high in the wall for ventilation and light rather than for viewing purposes. The addition of the supper room and kitchen is built in a smaller scale following the pitch and gable of the roof of the main hall. There is little landscaping as the hall is surrounded in gravel for easy parking.

The formation of the Denmark Masonic Lodge took place in 1946 when its first home was an old sawmill school building erected in c1896 (this has since been demolished). The Lodge then bought an old army hut on the riverbank. This proved only to be temporary as it was on Crown land. A building committee was formed which recommended a brick building. Plans were drawn up and submitted to the Grand Lodge in Perth who supplied a Master plan.

In 1953 a 'working bee' of mostly skilled workers constructed the Lodge Hall. Material from the old army hut was used in the construction of the new Lodge. A handsome bronze door knocker was a gift from a distinguished Brother in England. The financing of the Lodge was through loans of £720 from members plus donations and a bank overdraft. In 1986 the outside toilet and kitchen were replaced with a supper and preparation room.

The Masonic Hall has historic and social heritage significance. It represents the growth of social institutional groups in the Denmark area as the population expanded.

The Scout Hall used to be the site of Agricultural and Horticultural Shows which started in 1912. In 1968 under the energetic urging of Marge Nash the Denmark Scout group that had been dormant for many years was reformed. Along with her husband Andy and six other community leaders Marge formed a committee to build a scout hall incorporating the lean-to shed that had been part of the show grounds at McLean Park. Marge Nash had been an integral part of the Scout and Guide movement for many years having first become a Cub leader in 1934. On moving to Denmark she wished to continue this leadership and her energy and involvement did not cease until she retired from scouting at the age of 82.

Another member of the hall committee in 1968 was Beth Franz (nee Ridley) who became a Cub leader in 1969. Beth was one of the prime-movers of the committee and the money borrowed for the conversion from the Shire was paid back by vigorous fund raising over the years including theatrical shows called Dinner and Diversity events. Three of the old Albany Forts Buildings were purchased for \$100 each to use for the walls and floors. Beth's involvement with the Scouts movement since the 1960s has led to many awards for her community work, including the Centennial Medal and the Order of Australia Medal.

The Scout Hall, which was originally used as a basketball and recreation centre as well as a Scout and Guides Hall, was renamed in c1988 the Nash Franz Hall to recognise the contribution made by Andy and Marge Nash and Beth Franz. In 2009 the hall was no longer used as a recreation centre and the town's Guide movement was dormant. However, the Scouts were active with Joeys, Cubs, Scouts and a few Venturers.

Significance

Historic Theme: Community efforts
Sub Theme: Historic, social

The Franz Nash Scout hall has strong historic and social cultural heritage significance. The hall has a long association with the community efforts of Denmark, first as a place for Agricultural and Horticultural Shows and then from the 1960s as a scout hall. It represents the important contribution made by individual community leaders to form forums for youth recreation and education.

Level of Significance

Considerable

Very important to the heritage of the locality. High degree of integrity/ authenticity. Conservation of the place is highly desirable. Any alterations or extensions should reinforce the significance of the place.

Yurnga is situated in a prominent position above Hollings Rd, overlooking the river. It is a brick home with a tiled roof (though not thought to be original). The roof is a steeply pitched roof with a broken backed verandah shading the front facade. The house is symmetrical in design with a central door and wooden framed windows on either side.

History

Yurnga was built by Charles (known as CE) and Alice Smith in 1919 for their residence. CE was the prime mover of tourism in Denmark in the late 1920s, early 1930s operating his motor launch *Britannia* for fishing and camping parties to the Bar and Ocean Beach camping grounds. The Smith's also owned Springdale Guest House. CE died in 1936. Yurnga was later owned by real estate agent Mr Frank Harper in the 1950s whose wife is supposed to, whilst gardening, have dug up a jar containing 10,000 pounds, believed to date from CE Smith's days.



Significance

Historic Theme: Demographic settlement

Sub Theme: Aesthetic, historic, representative

Yurnga has aesthetic, historic and representative cultural heritage significance. The design of the house has small scale, decorative characteristics valued by the community. Built in 1919 this house was associated with a prominent businessman of the time and also represents a class of buildings constructed in a period of Denmark's expansion.
